

Western Hills Australian Shepherds Stud Service Agreement

We hereby signify agreement to the terms and provisions described below:

The Owner of the Bitch Agrees to:

- (1) Provide the stud dog owner with a complete pedigree, copies of OFA evaluations of hips and elbows, C.E.R.F. certification or a clear eye exam within the last year, and her ASCA, AKC, and or UKC registration papers.
- (2) Keep the bitch confined while in heat and assure she is not bred with any other stud dog. A mismatch-breeding before or after the stud dog service would render the stud dog service agreement void. Stud fee is not refundable.
- (3) Notify the stud owner within forty-eight (48) hours after the bitch whelps, or within a week after due date if no litter is whelped.
- (4) Cull puppies in accordance with the breed standard, with the regards to excess white (merle to merle breedings). Pattern white puppies' papers will be marked NOT FOR BREEDING and not culled.
- (5) All pet puppies papers MUST be marked NOT FOR BREEDING.
- (6) Keep a descriptive record of any puppy culled or that dies for the stud dog owner's records. This will include color, markings, gender, dewclaws, and tail length before litters papers are signed.
- (7) Have the tails docked, if do not have a natural bobtail. And front and rear dewclaws removed from all puppies before they age of five (5) days. Only reason this is not to occur is if selling to a foreign country where it is illegal.
- (8) Maintain a minimum-selling price of \$300 dollars or equal consideration on all puppies. And have a complete list of buyers for the stud dog owner's records.
- (9) The bitch owner agrees to have the bitch completely devoid of all fleas, ticks, and internal parasites when she enters the Western Hills kennel premise. She must have received her rabies, distemper, parvo, and bordatella vaccinations and be current or tittered.
- (10) The bitch owner agrees to pay all veterinary bills. If for any reason, the bitch accrues costs during her stay; unless the bills are due to negligence on the part of the stud dog owner.
- (11) Bitch must be 24 months of age or older.
- (12) Puppies from this cross shall not be sold to wholesalers, known puppy mills, miniature or toy Aussie breeders or pet dealerships.
- (13) Bitch owner agrees to provide pictures/video of litter prior to departure from bitch owner's premises. Pictures shall provide side shots (show side and off side), rear, and both sides of the head. These pictures should be taken between 5 weeks and 9 weeks.

The Stud Dog Owner Agrees to:

- (1) Provide the bitch owner with a complete pedigree, copies of OFA evaluation of hips and elbows, C.E.R.F. certification or a clear eye exam within the last year, and his ASCA, AKC, and or UKC registration papers.
- (2) Keep the bitch confined and safe while visiting the stud dog, and assure that she is not bred with any other stud dogs.
- (3) Guarantee a minimum of two (2) live puppies of acceptable color after culling (according to the ASCA and AKC breed standards), if this has not been met, then a repeat breeding to same or another approved bitch.
- (4) Give the bitch owner an itemized account of any expenses accrued during her stay at Western Hills kennels.
- (5) Sign registration papers if items (1-13) of the bitch agreement are fulfilled.
- (6) If the stud fee is a pick of the litter puppy, the decision will be made by 8 weeks of age and will be registered under the Western Hills kennel name.
